## Re: Freedom of Information Request FIRM 3910

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 27th June 2019.

Your request was received as follows: -

Q: Please can the trust outline any specific measures it has taken or is considering taking to mitigate the impact of pension tax charges on senior staff, which are causing some staff to reduce their hours or in some cases retire. I can confirm in accordance with Section1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not have any specific measures currently in place at the moment to mitigate the impact of pension tax charges on senior staff, this is currently being discussed therefore we are unable to provide this information. Under the FOI Act, we are not required to create this information in order to answer your request. I should explain that the FOI Act is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOI Act does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

## **Re-Use of Public Sector Information**

All information supplied by the Trust in answering a request for information (RFI) under the Freedom of Information Act 2000 will be subject to the terms of the Re-use of Public Sector Information Regulations 2005, Statutory Instrument 2005 No. 1515 which came into effect on 1st July 2005.
