Re: Freedom of Information Request FOI 4062

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 04th October 2019.

Your request was as follows:

1. How many patients are seen each year at Walton following surgery with Dr Gilete in Barcelona (Hospital Teknon)?

I can confirm in accordance with Section1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not collate information regarding surgery for external sources. Under the FOI Act, we are not required to create this information in order to answer your request. I should explain that the FOI Act is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOI Act does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

2. How many patients are seen each year at Walton following surgery with Dr Gilete in Barcelona (Hospital Teknon) that require further surgery at Walton?

I can confirm in accordance with Section1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not collate information regarding surgery for external sources. Under the FOI Act, we are not required to create this information in order to answer your request. I should explain that the FOI Act is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOI Act does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

3. How many patients are seen each year at Walton following surgery with Dr Gilete in Barcelona (Hospital Teknon) that require treatment to correct work done by Dr Gilete?


4. How many patients are seen each year at Walton following surgery with Dr Gilete in Barcelona (Hospital Teknon) that have received no benefit from the surgery?

5. How many Occipitocervical fusions are done at Walton each year?
