We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 24th October 2019.

Your request was as follows:

Please could you provide me with a spreadsheet/table showing the numbers of trousers that have been distributed to dieticians employed by your Trust in the 2018 calendar year where the waist measurement was 40inchs or more.

For each type of trousers please give a breakdown showing the waist size and the number of those waist sized trousers that were distributed.

The Walton Centre Foundation Trust (WCFT) can confirm that we have not issued any trousers with the waist measurement was 40 inches or more to dieticians employed by WCFT in the 2018 calendar year, therefore we cannot provide this information.
