**Re: Freedom of Information Request FOI 4048**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 24th September 2019.

Your request was as follows:

Could the trust please provide information on how much has been spent on agency nurses:

- 1) This financial year to date
- 2) 2018/19 financial year
- 3) 2017/18 financial year

Are these amounts higher, lower or within the budgets allocated for agency staff?

- We did not have an allocated budget specifically for agency staff during the 2017/2018 and 2018/2019 financial year as budget was split across agency and bank staff and was allocated based on the specialising of patients.
- For 2019/2020 the budget is once again split across bank and agency staff so no budget is specifically allocated for agency staff.

- 1) This financial year to date £52,919.93
- 2) 2018/19 financial year £740,558.47
- 3) 2017/18 financial year £1,300,389.86

Are there any measures being implemented to lower the reliance or use of agency staff?
