Re: Freedom of Information Request FOI 4414

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 07th August 2020.

Your request was as follows:

This is an information request relating to unpaid bills by overseas visitors.

By overseas visitors I am referring to people who live outside the EEA and Switzerland (non-EEA nationals), including former UK residents, who are not automatically entitled to free NHS care.

Please include the information for each of the following periods; 2019-20 and April 2020 to the present day:

- The total number of visitations by overseas visitors

19/20 - I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 40 (2) - Third Party Data

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of patients identified, and in answering your query may lead to the undue stress of families and patients as this information may still lead to patients being identified. Therefore this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test.

This response therefore acts as a refusal notice under section 17 of the FOIA.
