We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 12th August 2020.

Your request was as follows:

For the financial years 2015-16, 2016-17, 2017-18, 2018-19, and 2019-20, please provide the following information:

1. How much your trust has spent on translation/interpreter services (on both telephone and face-to-face and including British Sign Language)?

2014-15 £23,687.82 2015-16 £31,904.92 2016-17 £28,815.10 2017-18 £45,661.00 2018-19 £50,847.86 2019-20 £74,286.65

2. How much your trust has spent on the translation of written information for patients or carers?

We do not hold the figure for written information or translation services split. Therefore the information included in Question 1 will include any written information costs.

- 3. How much your trust has spent on the employment of translators/interpreters, and which languages these employees covered?
- £0 Here at The Walton Centre Foundation Trust (WCFT) we do not employ translators.
- 4. How much your trust has spent on employing advocates for non-English speakers?
- £0 Here at The WCFT we do not employ advocates for non-English speaking people.
- 5. What was the average waiting time for a consultation with an interpreter after initial request for interpreter services (for both telephone and face-to-face appointments)?

There is no wait. We currently arrange an outpatient appointment first and once this date is agreed with the patient we then arrange with the interpreter services. On the rare occasion that a interpreter is not available we explore other









options such as using a different interpreter services or using language line on the day of clinic before cancelling and rearranging the appointment.

6. Which company does the trust use for interpretation services?
