Re: Freedom of Information Request FOI 4555

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 09th December 2020.

Your request was as follows:

Please can you tell me how many Do Not Attempt Resuscitation (DNAR) notices were issued by the trust between 1st March 2020 and the present date (8th December 2020). Please include the date each DNAR was issued.

I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not hold information about DNAR notices that were issued for patients who were discharged from the Trust. Therefore we cannot provide this information.

Under the FOI Act, we are not required to create this information in order to answer your request. I should explain that the FOI Act is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOI Act does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

Please can you also tell me how many DNARs were issued for the same period last year (i.e. 1st March 2019 - 8th December 2019).

Please can you also tell me how many complaints you have received related to a DNAR being issued at any point between 1st March 2019-8th December 2020 and please provide as much detail as possible about the nature of the complaint.
