**Re: Freedom of Information Request FOI 4231**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 03rd February 2020.

Your request was as follows:

The type of any wrong route medication administration never events in the last three years e.g. Intravenous medication given intrathecally.

Due to the minimal number of patients identified, further information relating to any wrong route medication administration never events in the last three years will not be released under Section 40(3)(a)(ii) of the Freedom of Information Act 2000, as releasing this information may lead to the undue stress of families and patients as this information may still lead to patients being identified. Therefore this information has not been released for reasons of confidentiality; compliance with the Data Protection Act 2018 and by virtue of the exemptions contained in section 40(3) of the Freedom of Information Act 2000 as the Trust believes that providing the information would be in breach of the Principle (B) of GDPR as well as provisions under Chapter III regarding individuals' rights.
