We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 02nd July 2020.

Your request was as follows:



In response to your request, whilst we hold the information requested we believe an exemption under Section 12 of the Freedom of Information Act 2000 applies to it. Section 12 of the Act allows public authorities to refuse to answer requests for information if the cost of complying would exceed the 18 hour appropriate limit prescribed in the Fees Regulations.

In order to respond to your request this would require an audit person reviewing theatre notes. The time it would take to compile and collate the activity data required by means of a manual trawl of records would be in excess of this appropriate limit.

This response therefore acts as a refusal notice under section 17 of the FOIA.

However, Section 16 of the FOIA places a duty on us to provide help and assistance where possible and I am able to advise you that we have provided an attached excel spreadsheet which is a report which provides products The Walton Centre NHS Foundation Trust have ordered in the last year. This provides a figure of produces used overall but not per patient.
