We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 03rd July 2020.

Your request was as follows:

I am writing to request information on your organisations' overtime<sup>1</sup> and Waiting List Initiative<sup>2</sup> (WLI) Payments to staff. Please could you provide the following information broken down by staffing group, for the 19/20 financial year (April 2019 - March 2020)

- Overtime payments are defined as any payment for additional time beyond the standard FTE for the grade.
- WLI payments refers to any sessional payments made for additional time worked under a system called the Waiting List Initiative (used by trusts to reduce waiting lists and meet government targets)
