Re: Freedom of Information Request FOI 4377

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 10th July 2020.

Your request was as follows:

1. Has there been any changes to the pay band under the AFC agreement regarding the uplifts paid to the porters employed by ISS and who still come under the AFC agreement. This would be band two and would be time and forty four per cent and time and eighty eight per cent

In accordance with the NHS 3 year pay deal, annual payroll uplifts have continued to be paid at agreed rates to Porters employed by ISS who come under the AFC agreement at The Walton Centre NHS Foundation Trust. However unsocial hours payments for bands 1-3 have been calculated in a different way to protect the current value and improve it as basic pay increases over the three years. This calculation also prevents any 'leapfrogging' where staff in lower bands end up earning more than those in the next band up for the same unsocial hours shift.
