Here at The Walton Centre NHS Foundation Trust (WCFT) we have 8 Theatres.

- What is the number of ITU/Critical Care Beds by hospital within the Trust?

The WCFT has 20 critical care beds.

- Please can the Trust provide a list of all operating tables currently in theatres within the Trust to include:

- o Hospital
- o Manufacturer
- o Model
- o Installation date

The WCFT has the following operating tables: Maquet (manufacturer) Magnus (model) fixed table x1 installed February 2017 and also Maquet (manufacturer) Alpha star (models) tables x7 that have been in operation since July 2000.

- How many surgical pendant lights are currently installed in theatres within the Trust. Please will you list the:

- o hospital location
- o manufacturer
- o model
- o installation date

Here at WCFT we do not have any surgical pendant lights.

- How many surgical operating lights are currently installed in theatres within the Trust. Please will you list the

- o hospital location
- o manufacturer

o model

o date of installation

The WCFT has the following operating Lights; Starkstrom (manufacturer) Main and Satellite LED operating system x3 systems x1 installed 2013 x2 installed 2017 and also Hanalux 2007 (manufacturer) Main and Satellite operating light x5 systems installed 2007 these are all ceiling mounted and in all of the theatres.

• Does the Trust have an integrated theatre installation within theatres, and has this been rolled out across all theatre locations?
