Re: Freedom of Information Request FOI 4407

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 31st July 2020.

Your request was as follows:

Could you please tell me between 1st March 2020 and the date of this email (31st July 2020):

- 1) How many PALS enquiries and official complaints your Trust has received from patients concerned about
- a) the impact of the coronavirus pandemic and your Trust's response on their access to cancer treatment
- b) and access to cancer testing including tests to find out whether their cancer has spread, returned or occurred for the first time

NOTE: I suggest you search for these complaints by using the keywords 'cancer treatment', 'chemotherapy', 'cancer testing', 'coronavirus', 'COVID-19' and other relevant terms.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 40 (2) - Third Party Data

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of patients identified, and in answering your query may lead to the undue stress of families and patients as this information may still lead to patients being identified. Therefore this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test.

This response therefore acts as a refusal notice under section 17 of the FOIA.

- 2) For the five most recent PALS enquiries/official complaints received, please provide me with
- a) a summary of the complaint (e.g. a patient with stage 4 lung and breast cancer has contacted PALS to complain









about their chemotherapy being indefinitely suspended)

- b) the exact wording of the complaint, with redactions to remove potentially identifying information
- c) what action the Trust took in response N/A As above.
