Re: Freedom of Information Request FOI 4281

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 05th March 2020.

Your request was as follows:

Please could you kindly send me any information you may hold relating persons who have died with no known next of kin* (*defined as blood relatives, this would include patients who have listed next of kin but where such persons are friends or non-blood relatives) since 1/2/20 to the day of your reply, or as close as possible to this date. Please include:

- 1. full names of deceased persons,
- 2. dates of death,
- 3. marital status,
- 4. maiden surnames of married or widowed females,
- 5. dates of birth or ages at death,
- 6. last known addresses,
- 7. estimated value of estates, if known.

I confirm that The Walton Centre NHS Foundation Trust holds some of the information you have requested such as full names, date of death, marital status, maiden surnames of married of widowed females, date of birth or ages at death and last known address. We do not hold information on the estimated values of estates. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 31(1a) - The prevention or detection of crime

This information is exempt from disclosure under Section 31(1a) of the Freedom of Information Act 2000 (FoIA). We cannot provide personal information requested as your query on the grounds that the withheld information could be used to facilitate criminal acts such as identity fraud, theft of physical assets from a deceased's estate and criminal trespass. It points out that the requested information directly identifies deceased individuals in circumstances which could suggest that they did not leave relatives and did not leave a will. Consequently The Walton Centre NHS Foundation Trust asserts that disclosure of the requested information could make the assets and identity of those deceased persons vulnerable.

Section 21 - Information already reasonably accessible to you

This information is exempt from disclosure under Section 21 of the Freedom of Information Act 2000 (FoIA), as it is already reasonably accessible to you.

Section 41(1)(a)(b)- Information provided in confidence

This information was provided to the Trust whilst the patient was alive and had an expectation of confidentiality; therefore the The Walton Centre NHS Foundation Trust retains the duty of confidentiality after death.

This response therefore acts as a refusal notice under section 17 of the FolA.

Public Interest Test

To use this exception we are required to undertake a public interest test. The matters which were considered in applying the public interest test are as follows:

Factors in favour of disclosure:

- Disclosure of the data could potentially raise awareness of the general issue, as well as specific cases, increasing the number of cases where genuine beneficiaries can be identified.
- Disclosure of the data supports the general public interest in the transparency, accountability and general understanding of the delivery of public services.

Factors in favour of withholding:

- The Walton Centre NHS Foundation Trust does not recognise any specific public interest in the disclosure of the date of birth and maiden name of deceased individuals with no known next of kin.
- Disclosure of the exempted data will make it easier for the perpetration of criminal activities against the general public interest in a crime free society, as well as the public concern regarding the efficient use of police resources. Specifically, the theft of the identity of an individual through use of the disclosed data allows those intent on criminal activity the freedom to move around the country and instigate numerous criminal acts. The resources to resolve any criminal activity and track down the perpetrator will either need to be diverted away from other police activity, or will increase the overall cost to the public purse.

Re-Use of Public Sector Information


