**Re: Freedom of Information Request FOI 4290**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 13th March 2020.

Your request was as follows:

1. Copies of the computerised logs for the MRI scanner(s) confirming all scans which were undertaken at The Walton Centre on 3rd and 4th October 2014. This should include, in an anonymised format if necessary :
  - a) The number of MRI scans taken on each date.
  - b) The type of MRI scan taken - eg, lumbar spine, head, etc.
  - c) Whether each MRI scan was undertaken on an emergency or routine/elective basis.
  - d) The timings of each MRI scan.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

**Section 40 (2) - Third Party Data**

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of patients identified, and in answering your query may lead to the undue stress of families and patients as this information may still lead to patients being identified. Therefore this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test.

This response therefore acts as a refusal notice under section 17 of the FOIA.

2. Confirmation of the times the MRI scanner(s) operated at The Walton Centre on Friday 3rd and Saturday 4th October 2014. For example, was 24 hour access available on both dates?

As above.

3. Copies of the theatre logs for all surgery undertaken at The Walton Centre on 3rd and 4th October 2014. This

should include, again in an anonymised format if necessary :

- a) The type of operation/procedure performed.
- b) Whether each operation/procedure was undertaken on an emergency or routine/elective basis.
- c) The timings of each operation/procedure.
