Please can you provide the total agency spend for your Trust, for the last financial year, and the total hours supplied by temporary agency staff to your Trust, for the following staffing categories:

*I can confirm in accordance with Section1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not hold information regarding the total hours supplied by temporary agency for financial year 2019/2020.
