We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 24th November 2020.

Your request was as follows:

- 2. ICT Org Chart- A visual document that presents the structure of the IT department, please include name and job titles. If this cannot be sent, please work towards a structure with job titles.

If some of these documents are not valid, please state when the 2020 ICT documents are planned to be published.

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.


