Re: Freedom of Information Request FOI 4498

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th October 2020.

Your request was as follows:

1. we are writing to ask if you could send us any teaching materials about drug dose calculations used in your clinical skills course(s). Materials we would be looking for include;

- PowerPoint slides/lecture materials
- Worksheets
- Names and authors of textbooks that you recommend to your students
- Any other materials you may feel are useful

The kind of calculations we would be interested in for this research are drug dose calculations, for example;

- Weight- based dosing
- Volume of injection required for prescribed dose
- Volume of oral liquid required for prescribed dose
- Or any other calculations that you think are important for healthcare professionals to know in practice

Here at The Walton Centre we do not recommend any textbooks to students. We use a site called Medusa for our drug information including reconstitution information. Drug calculations are one aspect of drug administration, safe and competent use of correct infusion pump depending upon drug and amount being delivered is also important. Please find attached training materials that we use in our Trust.

2. We also ask if you can confirm which healthcare professionals are being taught these calculations.

Registered Nursing staff and on junior doctor induction they have a test paper on drug dose calculations / administration.
