## Re: Freedom of Information Request FOI 4453

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 11th September 2020.

Your request was as follows:

- 1. What proportion of emergency department images (x-ray, CT, MRI) were reported within the four-hour target\* in December 2018 and December 2019, categorised by each examination?
- \* Four-hour turnaround time for emergency department patients in line with In line with NHSE's four-hour A&E wait time standard

The Walton Centre NHS Foundation Trust is a Specialist Neuroscience Tertiary Care Centre; we do not have an Accident & Emergency Department and we do not report on 4 hour turnaround times, therefore we cannot provide this information.

- 2. What proportion of inpatient images (x-ray, CT, MRI) were reported within the 24-hour target\*\*, in December 2018 and December 2019, categorised by each examination.
- \*\* 24-hour reporting turnaround time for inpatient images, corresponding with NHS clinical standards for non-urgent inpatients

December 2018 Inpatient Same Day Turnaround - 67.33% December 2019 Inpatient Same Day Turnaround - 77.95%

3. How many radiology examinations (CT, MRI, x-ray) did your organisation conduct in 2018, 2019 and the first six months of 2020. Please can you provide the total number for each examination category for each year.

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.

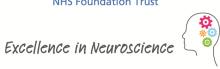
