Re: Freedom of Information Request FOI 4470

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 28th September 2020.

Your request was as follows:

a) How many adult's operations were cancelled at your Trust from 1 March 2020 - 31 August 2020?

Here at the Walton Centre NHS Foundation Trust (WCFT) 75 operations for patients over the ages of 16 were cancelled from 1 March 2020 - 31 August 2020.

Please note - WCFT only record 'last minute' cancellations as per national QMCO submission. During COVID there were a few cancellations when lockdown initially hit, this was then followed by a period of several months when operations were not being booked at all, therefore there was no operations to cancel. Since we re-opened in June we have done significantly fewer operations than normal, therefore there are less operations to cancel.

- b) How many adult's operations were cancelled at your Trust from 1 March 2019 31 August 2019? Here at WCFT 220 operations for patients over the ages of 16 were cancelled from 1 March 2019 - 31 August 2019.
- c) How many children's operations were cancelled at your Trust from 1 March 2020 31 August 2020? The WCFT does not treat patients under the age of 16; therefore we cannot provide this information.
- d) How many children's operations were cancelled at your Trust from 1 March 2019 31 August 2019? The WCFT does not treat patients under the age of 16; therefore we cannot provide this information.
