The Walton Centre NHS Foundation Trust is a Specialist Neuroscience Tertiary Care Centre; we do not have a Maternity Unit or provide Anaenatal care, however we do get referred patients who happen to be pregnant. If a pregnant patient wished to bring a partner with them to a face to face appointment because of covid restrictions we would not allow this, in more normal times we would allow a partner to come with them.
