## **Re: Freedom of Information Request FOI 4583**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 14th January 2021.

Your request was as follows:

1. Please provide the total number of whistleblowing concerns received between 01/03/2019 and 31/08/2019 by The Walton Centre NHS Foundation Trust

The number of concerns raised with the Freedom to Speak Up Guardian during this period is 10.

2. Please provide the total number of whistleblowing concerns received by The Walton Centre NHS Foundation Trust between 01/03/2020 and 31/08/2020

The number of concerns raised with the Freedom to Speak Up Guardian during this period is 15.

3. Please provide the following information for each whistleblowing concern received by The Walton Centre NHS Foundation Trust between 01/03/2020 and 31/08/2020:

a. A brief summary of the whistleblowing concern.

b. Whether any action was taken following the concern, and if so, a brief description of the action taken.

c. If the person provided the information anonymously (i.e. they did not provide you with their name and/or contact details) please indicate this.

3.a. and 3.b. I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 40 (2) - Third Party Data This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of patients and staff identified, and in answering your query it may lead to the undue stress of staff, patients and patient families as this information could lead to patients being identified. Therefore this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test.

This response therefore acts as a refusal notice under section 17 of the FOIA.

3.c. No concerns were raised anonymously.
