Re: Freedom of Information Request FOI 4790

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 30th June 2021.

Your request was as follows:

1) Please can you tell me how many cases of hospital-acquired Covid-19 the Trust has had since 1st March 2020 to the present day? Please break this down by probable and definite nosocomial infections if this data is available.

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.

Section 21 - Information already reasonably accessible to you

This information is exempt from disclosure under Section 21 of the Freedom of Information Act 2000 (FOIA), as it is already reasonably accessible to you. The information you have requested is published on NHS England website. Please use the following link:

This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.

2) Please also give me the number of deaths from hospital acquired infections (probable and definite cases). If you are able please state, in each case, if you have informed the patient's relative that it was a hospital acquired infection?

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested as we do not get informed of patient post-mortem results, therefore we cannot provide this information.

Under the FOI Act, we are not required to create this information in order to answer your request. I should explain that the FOI Act is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOI Act does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.
