Re: Freedom of Information Request FOI 4939

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 04th November 2021.

Your request was as follows:

In relation to FOI 4915:

You say you have 86 patient facing staff on Long Term Sick between 19th July 2021 and 1st October 2021 - What percentage is this of your workforce?

Also, how does this compare with the same date range in 2020 and 2019?

Here at the The Walton Centre NHS Foundation Trust in 2021 we had 86 staff long term sick out of 1069 staff in post which is 8.04%.

In 2020 we had 90 staff long term sick out of 1037 staff in post which is 8.68%.

In 2019 we had 94 staff long term sick out out of 1009 staff in post which is 9.32%.

Please see our response above in blue.
