We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 09th November 2021.

Your request was as follows:

- 1. We are interested in receiving the following information for each year in the period from 2018 to 2021 (please include total and year-by-year breakdown):
- a) The value of medicines wastage every year in The Walton Centre NHS Foundation Trust in £.

The Walton Centre NHS Foundation Trust does not have our own Pharmacy. We have a Service Level Agreement with Aintree University Hospital to provide Pharmacy Services; therefore we cannot provide this information.

- 2. We are interested in receiving the following information for each year in the period from 2018 to 2021 (please include total and year-by-year breakdown):
- a) The number of medicines in prefilled syringes procured for usage in the following departments within The Walton Centre NHS Foundation Trust:
- Intensive Care Units;
- Accident & Emergency departments;
- · Operating rooms.

The Walton Centre NHS Foundation Trust does not have our own Pharmacy. We have a Service Level Agreement with Aintree University Hospital to provide Pharmacy Services; therefore we cannot provide this information.

- 2.b) The names of the specific medicines which are procured in prefilled syringes for usage in the following departments within The Walton Centre NHS Foundation Trust:

- · Operating rooms.



a) The number of recorded cases of medication errors and adverse drug events resulting from the medication preparation of drugs prepared from vials and ampoules within The Walton Centre NHS Foundation Trust.
