## **Re: Freedom of Information Request FOI 4956**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 17th November 2021.

Your request was as follows:

We are undertaking a review of hospitals within the UK to see if superstition plays any role in the numbering of bed spaces or wards; focusing on the number 13. We would like to know the following:

• Do any of the hospitals within your trust have numbered wards? If so, which?

o Of these hospitals, do any have a ward numbered 13? If so, which?

o Additionally, these hospitals with numbered wards, are there wards numbered 12 and 14? (i.e. suggesting the intentional omission of a ward 13) If so, which hospitals?

The Walton Centre NHS Foundation Trust (WCFT) does not have numbered wards.

• Do the wards in your hospitals have numbered bed spaces? If so, which?

o Of these hospitals, do any of the wards have a bed space 13? If so, which?

o⊡Additionally, these hospital wards with numbered bed spaces, are there bed spaces numbered 12 and 14? (i.e. suggesting the intentional omission of a bed space 13) If so, which hospitals?

In WCFT all wards, Cairns, Caton, Chavasse, Dott, Sherrington, Horsley (ITU) and Jefferson day ward, plus Lipton and CRU both are Rehab wards have numbered bed spaces.

Horsley - side room 13, CRU - side room 13, Chavasse - side room 13

The following wards are not referred to as bed space 13 but are numbered on PAS the electronic system used -Sherrington (Bay 5 Bed 1 is bed 13), Caton (Bay 5 Bed 1 is bed 13), Cairns (Bay 4 Bed 6 is bed 13), Dott (Bay 4 Bed 5 is bed 13), Lipton (Bay 5 Bed 3 is bed 13)
