## Re: Freedom of Information Request FOI 4933

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 29th October 2021.

Your request was as follows:

Please can I have the information from 1st January 2019 to 28th October 2021 (or the most recent incident). I ask for the information to be broken down into years (2019, 2020, 2021).

1. ☐ The total number of physical assaults against NHS staff from members of the public and patients that occurred during 2019, 2020 and 2021.

2019 - 131

2020 - 185

2021 (to 28th Oct) - 116

2. ☐ The total number of verbal assaults against NHS staff from members of the public and patients that occured during 2019, 2020 and 2021.

2019 - 91

2020 - 69

2021 (to 28th Oct) - 78

3. □ Can you provide any more detail surrounding the nature of these incidents?

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

## Section 40 (2) - Third Party Data

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA). In answering your query may lead to the undue stress of staff and patients as this information would lead to staff and patients being identified. Therefore this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.

## **Re-Use of Public Sector Information**


