We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 25th April 2022.

Your request was as follows:

Under the Freedom of Information Act 2000, please can you tell us the number of unique patients since January 2020 with a recorded diagnosis of -

Please provide information on how each number was calculated (Using SNOMED CT, using ICD10, using both, another means.)

If any of the time periods are not available, please provide the closest possible time period.

Please provide the data in tabular format, a simple example of which is shown below.

1. Epilepsy. Likely coded as ICD G40

- 2. □ Dravet syndrome. Likely coded as ICD10 code G40.3, or SNOMED code (SCTID) of 230437002 (if applicable) Please see attached.
- 3. □ Lennox Gastaut Syndrome. Likely coded as ICD10 code G40.4 or SNOMED code (SCTID) of 230418006 Please see attached.
- 4. ☐ Tuberous Sclerosis Complex. Likely coded as ICD10 code Q85.1 or SNOMED code (SCTID) of 7199000 Please see attached.

How many patients have been treated with Cannabidiol (Epidyolex) in the latest 3 months?

For these patients, how many of them had a diagnosis of:-

Lennox-Gastaut syndrome (ICD10 Code: G40.4) SCTID: 230418006









Or how many of them had a diagnosis of:-

Dravet Syndrome (ICD10 Code: G40.8) SCTID: 230437002

The Walton Centre NHS Foundation Trust has issued Cannabidiol 100mg in 1ml oral solution to 24 patients since the 01/02/2022.

I can confirm in accordance with Section1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested relating to the diagnosis of each patient given Cannabidiol as a treatment.

Under the FOIA we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

Re-Use of Public Sector Information

All information supplied by the Trust in answering a request for information (RFI) under the Freedom of Information Act 2000 will be subject to the terms of the Re-use of Public Sector Information Regulations 2005, Statutory Instrument 2005 No. 1515 which came into effect on 1st July 2005.
