Your request was as follows:

I would like the organisation to review my freedom of information request below, that's focused around contract data for services around facilities management.

1. ☐ Office and building cleaning - Service contract that is focused around office, commercial and building cleaning services. ISS Facility Services (Mediclean). Annual cost £1,396,135. Contract start 01/04/2022 due to end 31/03/25 with optional two 1 year extensions. ISS also cover Security, Cleaning, Retail, Portering and Patient Feeding under this contract.

2. Lift service and maintenance - Service contract for lift service and maintenance. See attached

3. Food - Service contract that is focused around catering services. ISS Facility Services (Mediclean) £810,189. Contract start date 01/04/2022 with optional two 1 year extensions.

4. General waste services contracts - The organisation's primary general waste service contract. Bagnall and Morris, Contract start 01/04/22 due to end 31/03/25 with optional two 1 year extensions. Cost for 01/04/22 to 31/03/23 £19,626.83

5. Laundry services where clothes and linen can be washed and ironed. Aintree Linen services. Contract start 01/11/2019. Contract end - the Trust are currently in the 1st year extension option to 12/01/23 with an option for a further year thereafter. Cost £204,240.
