Re: Freedom of Information Request FOI 5323

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th August 2022.

Your request was as follows:

Please could you let me know about the services that you use to collect offensive and clinical waste

Clinical waste contract is with Bagnall and Morris (B&M) - volume for year 21/22 was 61.16 tonnes

Offensive waste contract is with SRCL - volume for 21/22 was 128.68 tonnes

Specifically, could you please let me know when you will next tender for these services, which framework you prefer and the annual tonnage for offensive waste and clinical waste?

B&M contract end date is 31/03/2025.

SRCL contract end date is 23/04/2023, however, there is an extension option available to the Trust.

Re-tendering will normally commence 3-6 months prior to contract end date. Procurement solution will be advised at the time by Trust Procurement Team but may be one of a number of different options.
