We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 16th May 2022.

Your request was as follows:

1.(a) Who is the head of procurement and is responsible for approving Nursing agency usage at this Service?

Steve Doran is the Head of Procurement for Health Procurement Liverpool (Health Procurement Liverpool is an alliance between Alder Hey Children's NHS Foundation Trust, the Clatterbridge Cancer Centre NHS Foundation Trust, LiverpoolHeart & Chest Hospital NHS Foundation Trust and The Walton Centre NHS Foundation Trust). Responsibilities for

managing Nursing agency contracts are delegated throughout the Procurement team across the alliance. Approval Process is as follows;

Divisional budget holders (and then Deputy Director of Finance, Director of Finance etc. depending on value and as perTrust Standing Financial Instructions/Scheme of Reservation and Delegation) are responsible for approving expenditure.

Procurement are responsible for the sourcing of providers as per NHSE/I Agency Expenditure guidance
