Re: Freedom of Information Request FOI 5456

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 23rd November 2022.

Your request was as follows:

1. The total outstanding medical bills currently owed to the Trust by overseas visitors. Please provide subtotals for each hospital within the Trust.

Please see attached.

2. The top three highest outstanding medical bills owed to the Trust by individual overseas visitors and the nationality of those visitors. (i.e. £495,000 owed by an individual from France)

Please see attached.

3. Of the total amount owed to the Trust, please provide a breakdown of the nationalities of overseas visitors who currently have outstanding medical bills (i.e. visitors from USA: £200,000 / visitors from Japan: £130,000)

Please see attached.

4. Please provide a breakdown of medical procedures that the outstanding medical bills relate to, for example £300,000 owed for Kidney disease treatments, for the Trust as a whole.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 12 - Requests where the cost of compliance exceeds the appropriate limit

In response to your request, whilst we hold the information requested we believe an exemption under Section 12 of the Freedom of Information Act 2000 applies to it. Section 12 of the Act allows public authorities to refuse to answer requests for information if the cost of complying would exceed the 18 hour appropriate limit prescribed in the Fees Regulations.

In order to respond to your request this would require an audit person reviewing every outstanding invoice and doing analysis on it to factor whether it is patient related debt or not, and then looking into the data behind each invoice to determine what procedures it relates to. The time it would take to compile and collate the activity data required by means of a manual trawl of records would be in excess of this appropriate limit.









This response therefore acts as a refusal notice under section 17 of the FOIA.
