Re: Freedom of Information Request FOI 5704

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 21st April 2023.

Your request was as follows:

1. How much has your Trust spent on specialist bariatric equipment for obese/bariatric patients (patients over 160kg) during the last five financial years? Please give a figure for each year: 2018/19, 2019/20, 2020/21, 2021/22, 2022/23.

I can confirm that the Walton Centre NHS Foundation Trust has spent the following on specialist bariatric equipment:-18/19 - £142,543.10

19/20 - £232,040.48 20/21 - £252,485.21 21/22 - £237,755.80 22/23 - £234,804.80

2. How many patients needed special adaptations due to their weight in the past 12 months?

The WCFT has had 6 patients needing specialist equipment over the last 12 months.

3. Please give a breakdown of the amounts spent by the Trust by the type of specialist bariatric equipment.

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested. Therefore we cannot provide this information.

Under the FOIA, we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

4. How many bariatric beds does the Trust own?

I can confirm that the WCFT do not own any beds but rent these as needed from Medstrom.

5. How many bariatric fridges does the Trust own?

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold this information. However, Section 16 of the FOIA places a duty on us to provide help and assistance where possible and I am able to advise you that: this information can be obtained from Aintree University Hospital.
