Re: Freedom of Information Request FOI 5863

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 03rd August 2023.

Your request was as follows:

I am writing under the Freedom of Information Act with a request for information.

Specifically I would like information regarding work on organ transplantation.

Please provide me with the details of collaborations with Chinese hospitals or universities on transplant medicine, research and training.

Please provide this information covering the dates 1/8/2018 to 1/8/2023.

In providing this information please give the start and end dates of any collaborations, the nature of the collaboration (for example doctor exchange, research projects).

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested as the Walton Centre NHS Foundation Trust does not carry out organ transplants or participate in research and training. Therefore, we cannot provide this information.

Under the FOIA, we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

Re-Use of Public Sector Information
