Re: Freedom of Information Request FOI 5910

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 31st August 2023.

Your request was as follows:

We kindly request the following information relating to the supply of Apomorphine products for the treatment of patients with Parkinson's disease in the care of the Walton Centre NHS Foundation Trust, and the provision of associated services to the Trust in connection with the administration of Apomorphine products to patients in the home:

1. □ Copies of any contracts and agreements (including amendment/variation agreements) between the Walton Centre NHS Foundation Trust and Britannia Pharmaceuticals Ltd in relation to the supply of Apomorphine products.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 43 (2) - Disclosure would, or would be likely to, prejudice the commercial interests of any person.

This information is exempt from disclosure under Section 43(2) of the Freedom of Information Act 2000 (FOIA). We cannot provide information requested as your query on the grounds that the withheld information would, or would be likely to, prejudice the commercial interests of any person (an individual, a company, the public authority itself or any other legal entity).

In order to apply section 43(2), the public authority must satisfy itself that disclosure of the information would, or would be likely to, prejudice or harm the commercial interests of any person.

If The Walton Centre did disclose this information this would affect, the Trust by damaging our reputation by disclosing confidential information given in confidence by a trusted supplier.

Public Interest Test

To use this exception, we are required to undertake a public interest test. The matters which were considered in applying the public interest test are as follows:

Factors in favour of disclosure:


- It would enable the public to better scrutinise the public monies spent.

- The contracts/agreements contain commercially sensitive information that could potentially be exploited by commercial competitors.
- Any confidential and commercially sensitive information which could be prejudicial to either parties' commercial interests will not be shared with any other parties or made available within the public domain.

This response therefore acts as a refusal notice under section 17 of the FOIA.

- 2. Copies of correspondence between the Walton Centre NHS Foundation Trust and Britannia Pharmaceuticals Ltd in relation to:
- a. ☐ the "treatment of disease, disorder or injury", "nursing care" or any other "regulated activities" (as set out in Schedule 1 of the Health and Social Care Act 2008 (Regulated Activities) Regulations 2014) by nurses employed by Britannia Pharmaceuticals Ltd in connection with the administration of Apomorphine products to patients in the care of the Walton Centre NHS Foundation Trust in the home; or
- b. registration with the Care Quality Commission (CQC); or
- c. □compliance with the Health and Social Care Act 2008 and associated subsidiary legislation.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 43 (2) - Disclosure would, or would be likely to, prejudice the commercial interests of any person.

This information is exempt from disclosure under Section 43(2) of the Freedom of Information Act 2000 (FOIA). Section 40 (2) - Third Party Data.

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the contents containing personal sensitive data of patients. In answering your query may lead to the undue stress of patients and families as this information may still lead to patients being identified. Therefore, this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.

3. □ Copies of any honorary contracts between the Walton Centre NHS Foundation Trust and any nurses providing homecare services to patients in the care of the Walton Centre NHS Foundation Trust on behalf of Britannia Pharmaceuticals Ltd.

We acknowledge that the requested documents may contain commercially sensitive information and/or personal data, which is consequently protected by confidentiality and/or data protection laws. However, we hope the Trust can still accommodate our request by redacting the relevant parts of the aforementioned documents where appropriate.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 40 (2) - Third Party Data.

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of staff identified as data requested is relating to 1-5 staff members. In answering your query may lead to the undue stress of staff as this information may still lead to staff being identified. The Walton Centre NHS Foundation Trust is bound by a duty of care to protect staff members from harm. Therefore, this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.

Please see our response above in blue.

Re-Use of Public Sector Information

All information supplied by the Trust in answering a request for information (RFI) under the Freedom of Information Act 2000 will be subject to the terms of the Re-use of Public Sector Information Regulations 2005, Statutory Instrument 2005 No. 1515 which came into effect on 1st July 2005.
