**Re: Freedom of Information Request FOI 5592**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 14th February 2023.

- b. Who provides your SIP trunks and what is the annual spend
- c. Who provides your WAN services, is this MPLS, SD WAN or Internet, and what is the annual spend
- d. Who provides your LAN infrastructure and what is your annual spend
- e. Who provides your WIFI infrastructure and what is your annual spend
- f. Please confirm the manufacturer(s) of your wired network core and edge switching?
- g. When was your core network installed?
- h. Has it been updated subsequently?
- i. Who maintains your core network?
- j. When is the contract renewal date?
- k. Please confirm value of the initial project?
- l. Please confirm the value of annual support/maintenance services (in £)?

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.
