We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 17th January 2023.

Your request was as follows:

- During the last financial year how many nurses, doctors or AHP have been recruited internationally via an agency?

- How much spend has been used for international recruitment?

- What agencies do you currently use for international recruitment?

- How many vacancies do the Trust have for nurses, doctors and AHPs?

- During the last financial year how many nurses, doctors or AHP have been recruited internationally via an agency? The Walton Centre NHS Foundation Trust (WCFT) can confirm 22 recruitments have been made via an agency.

- How much spend has been used for international recruitment? International recruitment spend in 21/22 was £601,218.

- What agencies do you currently use for international recruitment? The WCFT use NHS Professionals International.

AHPs - 6.61
