Re: Freedom of Information Request FOI 5545

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th January 2023.

Your request was as follows:

I am getting in touch to request information under the Freedom of Information Act. The request relates to the amount of money spent by your NHS Trust on first class and business class tickets for flights from 2019 to the first few weeks of 2023.

1. Over the last four years, has your Trust booked first class or business class plane tickets for staff/employees to travel on work trips abroad?

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested as the Walton Centre NHS Foundation Trust has not ordered or approved any Business or First-Class flights in the timeframe requested; therefore we cannot provide this information.

Under the FOIA, we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.
