Your request was as follows:

Please can I request the following information under the Freedom of Information act.

1. Do you currently use any off framework agencies for Nursing, if so please include agency name?
2. Do you currently use any off framework agecniies for HCA/support workers, if so please include agency name?
3. Since May 2023 till now, how many shifts have been booked with off framework agency for nursing?
4. Since May 2023 till now, how many shifts have been booked with off framework agency for healthcare assitant/support workers?
5. Do you have any off framework agencies who currently charge £50+ per hour for nursing staff, if so who may they be?
6. Do you have any off framework agencies who currently charge £24+ per hour for healthcare assitant/support workers, if so who may they be?

I can confirm that the Walton Centre NHS Foundation Trust do not use off framework agencies, therefore we are unable to provide this information.
