## Re: Freedom of Information Request FOI 5627

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 06th March 2023.

Your request was as follows:

Under the FOI Act please provide me with the information below.

Please confirm receipt of this request as soon as possible.

Please provide this as a series of data points for the last calendar year and the year to date, broken down by day. For

I am aware that some of the data showing the total number of delayed transfers of care is published

For example, the Welsh Government also used to publish a detailed breakdown of reasons behind delayed discharge

Please provide this data in a spreadsheet format such as excel or a .csv file, with columns for the date, total number of patients and reasons for delay.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 12 - Requests where the cost of compliance exceeds the appropriate limit

In response to your request, whilst we hold the information requested we believe an exemption under Section 12 of the Freedom of Information Act 2000 applies to it. Section 12 of the Act allows public authorities to refuse to answer requests for information if the cost of complying would exceed the 18 hour appropriate limit prescribed in the Fees Regulations.

In order to respond to your request this would require an audit person reviewing each discharge during the timeframe









requested, splitting the data into the different categories you have asked for. The time it would take to compile and collate the activity data required by means of a manual trawl of records would be in excess of this appropriate limit.

However, Section 16 of the FOIA places a duty on us to provide help and assistance where possible and I am able to advise you that: if you refine your request to ask only for the total monthly figures of delayed discharges with the breakdown of the various reasons for the delays.

This response therefore acts as a refusal notice under section 17 of the FOIA.

## **Re-Use of Public Sector Information**
