- Ocrevus (ocrelizumab)
- Plegridy (peginterferon beta-1a)
- Ponvory (ponesimod)
- Rebif (beta interferon-1a)
- Tecfidera (dimethyl fumarate)
- Tysabri (natalizumab)
- Tysabri (natalizumab) pre-filled syringes ONLY
- Vumerity (diroximel fumarate)
- Zeposia (ozanimod)

It would also be very helpful if you could advise how many hospital patients registered with your trust/health board have a primary or secondary diagnosis for the the following conditions:

- Multiple sclerosis (any type)
- Relapsing remitting multiple sclerosis (RRMS)
- Primary progressive multiple sclerosis (PPMS)
- Secondary progressive multiple sclerosis (SPMS)

I can confirm the Walton Centre NHS Foundation Trust has 1930 distinct patients between 1/11/2022 and 30/04/2022 were coded with MS.
