Re: Freedom of Information Request FOI 5733

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 12th May 2023.

Your request was as follows:

I am writing to submit a formal Freedom of Information (FOI) request under the Freedom of Information Act 2000. I kindly request your assistance in providing me with information regarding the prevention strategies implemented or planned by your NHS Trust (if available) in line with the NHS Long-Term Plan 2019.

Specifically, I am interested in obtaining details about the measures, initiatives, and actions taken by your NHS Trust to address the "prevention" aspect outlined in the NHS Long-Term Plan. This may include but is not limited to:

Strategies or programs focused on promoting healthy lifestyles and preventing diseases.

Initiatives aimed at reducing health inequalities and improving access to preventive healthcare services.

Collaborations with local authorities, community organizations, or other healthcare providers to enhance prevention efforts.

Allocation of resources or funding for prevention activities.

Policies or guidelines related to preventive healthcare services.

This may be referred to as a "prevention strategy". I would like to see any overarching prevention strategies from the trust, not individual departments.

I can confirm that the Walton Centre NHS Foundation Trust have formed a partnership with LUHFT CURE Team who provide stop smoking services via a referral system for our inpatients. As a Trust we do not have our own stop smoking services so we have joined in partnership with LUHFT CURE Team who have been tasked by the ICB to improve this for patients. Nicotine replacement products have been reviewed and increased as required to meet the service demand and staff can arrange for patients to commence NRT when requested. Any inpatient who identifies that they are happy to speak with our CURE Team stop smoking service will then be referred. If they have been discharged they will have a one week follow up before being referred to relevant community services. Nicotine replacement products are prescribed as requested, taking into account any contraindications. This initiative has been fully funded by the ICB.

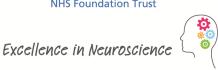
Re-Use of Public Sector Information
