Re: Freedom of Information Request FOI 5746

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th May 2023.

Your request was as follows:

Could you provide me with a breakdown of spend on agency nurses and midwives between May 2022 and May 2023 as below

- o Number of shifts invoiced by each provider trust has used for agency nursing
- o Framework spend on agency nursing and midwifery broken down to spend per Framework provider
- o Off-framework spend on agency nursing and midwifery broken down to spend per off-framework provider

I can confirm that between May 22 and May 23 the Walton Centre NHS Foundation Trust spent £3,909 on a total of 11 agency shifts with no framework or off-framework spend. (Please note all other shifts were covered by NHSP bank staff)
