## **Re: Freedom of Information Request FOI 5759**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 30th May 2023.

Your request was as follows:

Under the Freedom of information act (2000) I require the following. Information.

1. Is complex regional pain syndrome a brain injury and severe pain condition?

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.
