Re: Freedom of Information Request FOI 6040

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 21st November 2023.

Your request was as follows:

I am writing to you under the Freedom of Information Act 2000 to request the following information regarding complaints received by THE WALTON CENTRE NHS FOUNDATION TRUST between 1st September 2022 and 31st August 2023 (inclusive). Specifically, I would like to know:

How many women inpatients complained that a trans woman inpatient was being cared for in the same ward as the complainant?

For the avoidance of doubt, it may be helpful for me to note that my question is in reference to written complaints (which may have been originally made orally and subsequently recorded in writing) received by the Trust.

I can confirm that the Walton Centre NHS Foundation Trust have not received any complaints related to trans women inpatients being cared for in the same ward as a CIS woman inpatient.
