Re: Freedom of Information Request FOI 6048

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 27th November 2023.

Your request was as follows:

1. Since 1st January 2022 how many staff have been given permission to work remotely outside of the UK?

I can confirm that since the 1st January 2022, the Walton Centre NHS Foundation Trust have granted permission to one member of staff to work remotely outside of the UK.

2. Please provide a list of each unique approval detailing; country, job title of the individual concerned and length of time spent working outside of the UK.

I confirm that The Walton Centre NHS Foundation Trust holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it:

Section 40 (2) - Third Party Data

This information is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000 (FOIA), due to the minimal number of staff identified as data requested is relating to a single staff member. In answering your query may lead to the undue stress of families and staff as this information may still lead to staff being identified. Therefore, this information has not been released for reasons of confidentiality.

This exemption is not subject to the public interest test. This response therefore acts as a refusal notice under section 17 of the FOIA.

3. Are there any additional associated costs created by staff working outside of the UK. Please provide a breakdown of these costs and the total spent since 1st January 2022.

I can confirm that there are no additional associated costs.
