I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold this information as the Walton Centre NHS Foundation Trust do not have a mortuary. However, Section 16 of the FOIA places a duty on us to provide help and assistance where possible and I am able to advise you that this information may be obtained through Liverpool University Hospitals.
