**Re: Freedom of Information Request FOI 5993**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 19th October 2023.

Your request was as follows:

1.  What IT systems and applications are you planning to replace or upgrade over the next year?

I can confirm that there are no plans around upgrading of systems at the present moment here at the Walton Centre NHS Foundation Trust.

2.  Are you looking to complete a HIMSS INFRAM assessment in the next twelve months?

No, the WCFT will be using NHS DMA v2 next year.

3.  When are you planning to review your Digital Strategy?

The WCFT Digital sub strategy is due for review in 2025.

4.  Please supply a copy of the Trust's most recent Digital Strategy.

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.
