## Re: Freedom of Information Request FOI 5996

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 20th October 2023.

Your request was as follows:

Is your trust a member of a salary sacrifice scheme for a car? If so, which scheme are you a member of?

The Walton Centre NHS Foundation Trust are a member of the NHS Fleet salary sacrifice scheme for a car.

What is the total number of staff in your trust that have taken advantage of a salary sacrifice scheme for a car? What is the average amount of subsidy across the cars in your scheme.

The WCFT have 192 staff using the salary sacrifice scheme. We are unable to provide the average subsidy as the Trust do not record this in a way it can be averaged out due to varying lease lengths.

What is the total number of staff that have taken advantage of a salary sacrifice scheme for a car are non-clinical? I would like this information broken down by staff role, i.e nurse, consultant etc.

The WCFT have 26 non-clinical staff using the salary sacrifice scheme, we only record non-clinical staff as admin and clerical.
