Re: Freedom of Information Request FOI 6012

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 30th October 2023.

Your request was as follows:

1. What geographic area are you in?

The Walton Centre NHS Foundation Trust is a specialist care centre based in Liverpool.

2. Are you connected to any other trusts, and if so, how?

The WCFT is based on the same site as Aintree University Hospital.

3. What is your current financial strength - green, yellow, red, etc?

I can confirm in accordance with Section 1 of the Freedom of Information Act 2000 (FOIA) that we do not hold the information you have requested as we do not record the information in this manner. Therefore we cannot provide this information.

Under the FOIA, we are not required to create this information in order to answer your request. I should explain that the FOIA is to do with transparency of information held by public authorities. It gives an individual the right to access recorded information held by public authorities. The FOIA does not require public authorities to generate information, or to answer questions, provide explanations or give opinions, unless this is recorded information that they already hold.

I confirm that The Walton Centre NHS Foundation Trust (WCFT) holds the information you have requested. However, I am unable to provide you with that information as I consider that the following exemptions apply to it.
